SUMMARY ANNUAL REPORT FOR ODYSSEY SYSTEMS CONSULTING GROUP, LTD HEALTH AND WELFARE PLAN

This is a summary of the annual report of the ODYSSEY SYSTEMS CONSULTING GROUP, LTD HEALTH AND WELFARE PLAN, a health, life insurance, dental, vision, temporary disability, long-term disability and death benefits plan (Employer Identification Number 04-3373471, Plan Number 501), for the plan year 03/01/2022 through 02/28/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

ODYSSEY SYSTEMS CONSULTING GROUP, LTD has committed itself to pay certain Dental claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with BLUE CROSS BLUE SHIELD OF MASSACHUSETTS, INC., EYEMED VISION CARE, RELIASTAR LIFE INSURANCE COMPANY and LINCOLN NATIONAL LIFE INSURANCE COMPANY to pay certain Health, Vision, Life insurance, Temporary disability, Long-term disability, Accidental Death & Dismemberment, Worksite Benefits claims incurred under the terms of the plan. The total premiums paid for the plan year ending 02/28/2023 were \$4,849,187.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 02/28/2023, the premiums paid under such "experience-rated" contracts were \$4,235,650 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$3,366,949.
